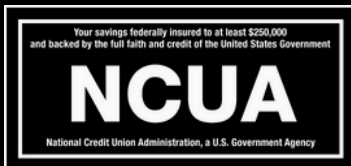

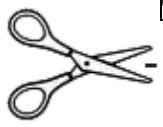

CHRISTMAS SKIP-A-PAY

If you would like to skip-a-payment on your HCFCU loan, you request that HCFCU defer your loan payments as indicated. You agree and understand that: 1) finance charges will continue to accrue at the rate provided for in your original loan agreement, during and after that time; 2) deferring your next payment will result in your having to pay higher total finance charges than if you made your payments as originally scheduled; 3) this payment deferral will extend your loans(s) and you will have to make extra payment(s) after your loan(s) would otherwise be paid off; and 4) you will be required to resume your regular monthly payments in the following month. If you previously elected credit life and/or disability insurance, the insurance coverage will not be extended beyond the original maturity date. All skip-a-pays subject to HCFCU approval. All other terms and provisions of the original term of the loan agreement will remain unchanged and in full force and effect.
